What's Happening in Southern California According to California law, your employer MUST have Worker's Compensation insurance to cover these expenses. Without this coverage an employer risks steep fines, business closure and criminal charges. However, even if your employer is uninsured, you can still receive the benefits to which you're entitled.

#### What to Do if You are Injured at Work

First, report your injury to your employer by completing a <a href="DWC1 Claim Form">DWC1 Claim Form</a> as soon as possible.

If your employer is uninsured you have several options for claiming your benefits:

- Your employer may choose to pay your medical bills and make disability payments directly.
- You may sue for benefits in a civil court if your employer is unable or unwilling to make payments.
- You may choose to go before a judge to get a settlement with your employer. You must work with an officer at your local Worker's Compensation <u>Information & Assistance (I&A)</u> office.

### **Apply for UEBTF Benefits**

Another way to receive benefits is to apply for payments through <u>California's Uninsured Employers</u>

<u>Benefit Trust Fund (UEBTF)</u>, a special fund established for workers who become ill or are injured

while working for an illegally uninsured employer.

The application process is lengthy but just take it one step at a time. See <u>Guide 16</u> for the complete step by step process:

- Open your case at your local Worker's
   Compensation office see <u>Guide 1</u>.
- Provide the correct legal name of your employer –
   see <u>Guide 16 (A)</u>.
- Serve, or deliver, completed copies of certain documents to your employer – see <u>Guide 16 (B)</u>.
   You cannot do this yourself, but must work through a law office or a process server, as explained in the Guide.

This process must be completely accurate in order to get a favorable determination. We advise you to reach out to an <u>attorney experienced in all aspects of California Worker's Compensation</u>, including UEBTF applications. Recipe of the Month:

**Hearty Squash Soup** 



## **Ingredients**

- 6 cups (about 2 large squash) seeded 2-inch wide chunks butternut squash
- Melted butter, for brushing
- 1 tablespoon kosher salt, plus 1 teaspoon
- 1 teaspoon freshly ground white pepper, plus ½ teaspoon
- 3 cups chicken or vegetable stock
- 4 tablespoons honey
- 1 teaspoon minced ginger
- 4 ounces heavy cream
- ¼ teaspoon nutmeg

#### **Directions:**

Preheat the oven to 400 degrees F.

Brush the flesh of the squash with a little butter and season with 1 tablespoon salt and 1 teaspoon freshly ground white pepper. On a sheet pan lay the squash flesh side up. Roast for about 30 to 35 minutes or until the flesh is nice and soft.

Scoop the flesh from the skin into a pot and add the stock, honey, and ginger. Bring to a simmer and puree using a stick blender. Stir in the heavy cream and return to a low simmer. Season with salt, pepper, and nutmeg.


