# Social Security Benefits and Same Sex Couples

In a landmark case, on June 26,

2015 the U.S.

Supreme



Court issued a decision stating that same—sex couples have a constitutional right to marry in all states and the District of Columbia. Essentially, this decision gives the same marriage rights to same—sex couples that heterosexual couples receive.

The 2015 decision came on the heels of an earlier 2013 ruling where the Court opened the door for same—sex married couples to have the same eligibility for federal benefits as traditional married couples. However, same—sex couples residing in states that did not recognize their marriage did not have that same opportunity until this year.

### **Social Security Benefits**

The decision has profound implications for the financial aspects of marriage including taxes, IRAs and estate planning. There are also important eligibility changes for Social Security benefits.

Previously, same—sex couples did not qualify for spousal Social Security Retirement (SSR) or Social Security Disability (SSDI) benefits if the marriage wasn't legally recognized. With the marriages now considered legal, workers and spouses will have more options when applying for benefits. For example, a lower-earning spouse can have access to the higher—earning spouse's earning records.

Also, a spouse of a disabled worker who is collecting SSDI benefits may be able to receive a spousal disability benefit. This is valuable protection for a family whose major breadwinner is no longer able to work. Importantly, eligible children of same-sex couples now can receive SSR, SSDI and survivor benefits.

# Status of Same–Sex Couples Social Security Applications

The Social Security Administration's <u>website</u> states that the agency is still working with the Department of Justice to analyze the Court's decision and provide more instructions for claimants.

Until then, applicants who believe they may be eligible for benefits are encouraged to <u>apply</u> right away.

# Special Information for Those Receiving Supplemental Security Income

Same—sex marriages count in determining eligibility for <u>Supplemental Security Income</u> and the amount of payment. All changes including marital status must be reported to the Administration.

# The Hollywood Bowl: A Treasured Landmark

One of Southern California's most sparkling gems is the <u>Hollywood</u>

<u>Bowl</u>. Besides being the seasonal home of both the Los Angeles



Philharmonic and the Hollywood Bowl Orchestra, it's a mecca for summer music in all genres and a public park and picnic ground.

The Bowl's humble origins began in a natural amphitheater known as the "Daisy Dell" Bolton Canyon. Its inaugural performance was at an Easter sunrise service in 1921 complete with makeshift wooden benches and a simple awning over the stage. Since then, virtually every renowned classical artist and conductor has performed at this stunning venue.

An early highlight at a 1938 performance of Wagner's opera Die Walküre included genuine fire and smoke along with costumed Valkyries riding white horses down the hillsides. Not to be outdone, coloratura Lily Pons set the attendance record in 1946 at 25,410 tickets! However, a different seating configuration and stricter fire regulations now keep the maximum seating level at a more manageable 17,376.

The Beatles' 1964 show where tickets sold out in 3 ½ hours saw hundreds of teenaged girls camping out on nearby streets. Since then, the <u>list</u> of stars and groups appearing at the Bowl reads like a virtual "Who's Who" of rock and roll.

Dance events have included Moscow's Bolshoi Ballet at the height of the Cold

War in 1967. At that same event, folk dance groups from Ukraine, Azerbaijan and Georgia also performed and the lines of ticket buyers stretched from the box office down an adjacent street. Dance performances now showcase diverse companies including India, China, Mexico, Brazil and West Africa.

# **Gingerbread-Pumpkin Yule Log**



## **Ingredients**

- 3 eggs
- Nonstick cooking spray for baking
- 1 cup all–purpose flour
- 1 teaspoon baking powder
- 1 teaspoon pumpkin pie spice
- ¼ teaspoon salt

- ½ cup granulated sugar or sugar substitute blend\* equivalent to ½ cup sugar
- ½ cup canned pumpkin
- ¼ cup molasses
- Powdered sugar
- 1 recipe Pumpkin Cream Filling (see below)
- Fresh rosemary sprigs (optional)
- Fresh cranberries (optional)

#### **Directions:**

- 1. Allow eggs to stand at room temperature for 30 minutes. Meanwhile, lightly coat a 15x10x1-inch baking pan with nonstick spray for baking. Line the bottom of the pan with waxed paper or parchment paper; coat with nonstick spray for baking. Set pan aside. In a small bowl, stir together flour, baking powder, pumpkin pie spice, and salt; set aside.
- 2. Preheat oven to 375 degrees F. In a large bowl, beat eggs with an electric mixer on high speed for 5 minutes. Gradually add granulated sugar, beating until well mixed. Stir in pumpkin and molasses. Fold in flour mixture. Spread batter evenly into prepared pan.
- 3. Bake about 15 minutes or until top springs back when lightly touched. Immediately loosen edges of cake from pan and turn cake out onto a towel sprinkled generously with powdered sugar. Slowly peel off waxed paper. Starting from a short side, roll up towel and cake into a spiral. Cool on a wire rack for 1 hour. Meanwhile, prepare Pumpkin Cream Filling.
- 4. Unroll cake; remove towel. Spread cake with Pumpkin Cream Filling to

within 1 inch of edges. Roll up cake and filling into a spiral. Trim ends. Cover and chill for 2 to 48 hours before serving. To serve, place cake roll on a platter. If desired, garnish with rosemary sprigs and cranberries and sprinkle top with powdered sugar. Makes 10 servings.

## **Pumpkin Cream Filling**

# **Ingredients**

- ¾ cup canned pumpkin
- ½ teaspoon ground ginger
- 1 ¼ cups frozen light whipped topping, thawed

#### **Directions:**

1. In a medium bowl, combine pumpkin and ground ginger. Fold in thawed frozen light whipped dessert topping.


