# How a Social Security Disability Hearing Works

If you've applied for Social Security Disability (SSDI) benefits and your initial application was denied, you should always request that your claim be reconsidered within 60 days.

If your SSDI Reconsideration claim is again denied, you have the right to request a hearing before



an Administrative Law Judge. At this point we strongly urge that you work with an attorney experienced in SSDI appeals to present the best case for your application.

Currently in L.A. it can take up to 18 months after your request for your hearing to take place (Social Security - Average Wait Time). Be sure to consult your attorney well in advance of the hearing date for adequate time to review your case with you.

## What To Expect at Your Claim Hearing

The Administrative Law Judge will tell you when and where to go for your hearing. Don't worry - you won't have to go to a formal courtroom and there won't be a jury or audience. The hearing location will be one that is convenient for you like your local Social Security office.

You should make every effort to appear at the hearing! If you don't have a valid reason for not attending the hearing as scheduled, the judge may dismiss your hearing. Video-conferencing is available in most locations to make scheduling easier. You can invite your attorney, supportive family members or any witnesses that can help your case to attend.

The Administrative Law Judge will manage the proceedings and make a decision on your case. There may also be medical and vocational experts present who can answer questions about your medical condition and your job.

A court reporter may be present to record your hearing as part of the documentation of your case. ....continued on page 2

# **Answering Questions at Your Disability Hearing**

- · Listen carefully to the judge's questions and give direct answers.
- Don't give extra information stick to the question.
- · Be specific about your symptoms and how they limit your lifestyle and working ability.
- · Be ready to describe your daily living and how it's been affected by your disability.
- · Always be honest and don't exaggerate anything.

# What is a Social Security Disability Freeze?

Due to your Social Security disability and retirement benefits being determined by an average of your historical earnings, having little or no income for a period of time can lower your monthly Social Security benefits when you need to use them. To decrease the impact of these little or no income periods on your overall benefits, the Social Security Administration (SSA) created a "disability freeze." A disability freeze is a period where the SSA won't consider your income when calculating your future benefits. # **History of Trains in California: A Colorful History**

Although California attained statehood in 1850, our state was isolated on the Pacific Ocean until the First Transcontinental Railroad was completed. Before that magical golden spike was driven in Promontory Summit, Utah in 1869, anyone traveling to California had to go by ship, an arduous journey around the tip of South America that took 5-8 months. Overland routes were full of dangers from diseases to attacks by hostile Indians.

Further development of train transportation to California paralleled various economic development periods. The initial push for trans-continental trains was in response to the Gold Rush of 1849.



Train transport was the logical choice to help distribute California's agricultural bounty to the rest of the country and soon the Pacific Fruit Express was shipping produce in refrigerated cars.

By 1915 transporting oil in steel tank cars was big business and train engines were converted to run on oil instead of coal.

The Atchison, Topeka and Santa Fe Railroad, immortalized in Johnny Mercer and Harry Warren's 1944 song, chose Los Angeles as its western terminus in 1885, digging into the Southern Pacific Railroad transportation monopoly.

The San Diego electric railway, created in 1892, helped to urbanize San Diego as did the Pacific Electric Railway in Los Angeles and Orange Counties.

Rail tourism began in the 1870's but leisure travel by rail really kicked in 60 years later. Sadly, the "Golden Age" of railroading ended when automobile and air traffic became more popular and also cost-effective.

Today, Amtrak provides interstate train travel for our state and several intercity lines connect various regions.

- 1 medium onion, cut into thin wedges

- 1-1/2 teaspoons brown sugar
- 1/4 teaspoon salt
- 1/8 teaspoon pepper
- 1/8 teaspoon ground nutmeg

- 1. Preheat oven to 450°. Place the squash and onion in a greased 13x9-in. baking dish. Combine cider, oil, brown sugar, salt, pepper and nutmeg; pour over squash mixture.

2. Cover and bake 35 minutes or until tender, stirring every 10 minutes. Yield: 4-6 servings.
