Applying for Social Security Disability: Frequently Asked Questions

If you or a family member is unable to work because of a disability, you probably have a lot of questions about Social Security Disability (SSDI) benefits. Applying for SSDI is a complex process and it can be confusing.

First of all, we are here to help! Many initial SSDI claims are

rejected, often because information is incomplete or missing. It's important to get guidance from an attorney experienced in SSDI applications to avoid delays.

Here are answers to common questions that we hear every day:

When should I apply for SSDI? You should apply when you have been unable to work for at least 5 months. If you have been off work than 5 months, your claim may be denied because your condition is not severe enough to keep you out of work for a year or more.

How long will it take to get my claim approved? There are significant delays in processing SSDI applications in California because of the huge volume that processors must handle. Initial applications can take 4 months and the majority are denied at this stage. If your application is denied, request a Reconsideration and supply any information that is missing. If the Reconsideration is again denied, applicants should file a request for an Administrative Law Judge hearing. At this hearing it is essential to have experienced legal representation to help present your case.

What kind of evidence must I supply with my application? Your best chance of approval is to submit an application with complete, relevant information. Be sure to include your medical history and information on all treatments, physician names and contact information, treating hospitals and clinics, lab and test results, list of medications and a physician statement how your health problems affect your ability to work. Once approved, are benefits paid retroactive to my disability date? All SSDI applicants must wait for 5 months after they apply to receive benefits. If you apply for SSDI some time after your actual disability date, you can receive back pay for a maximum of 12 months.

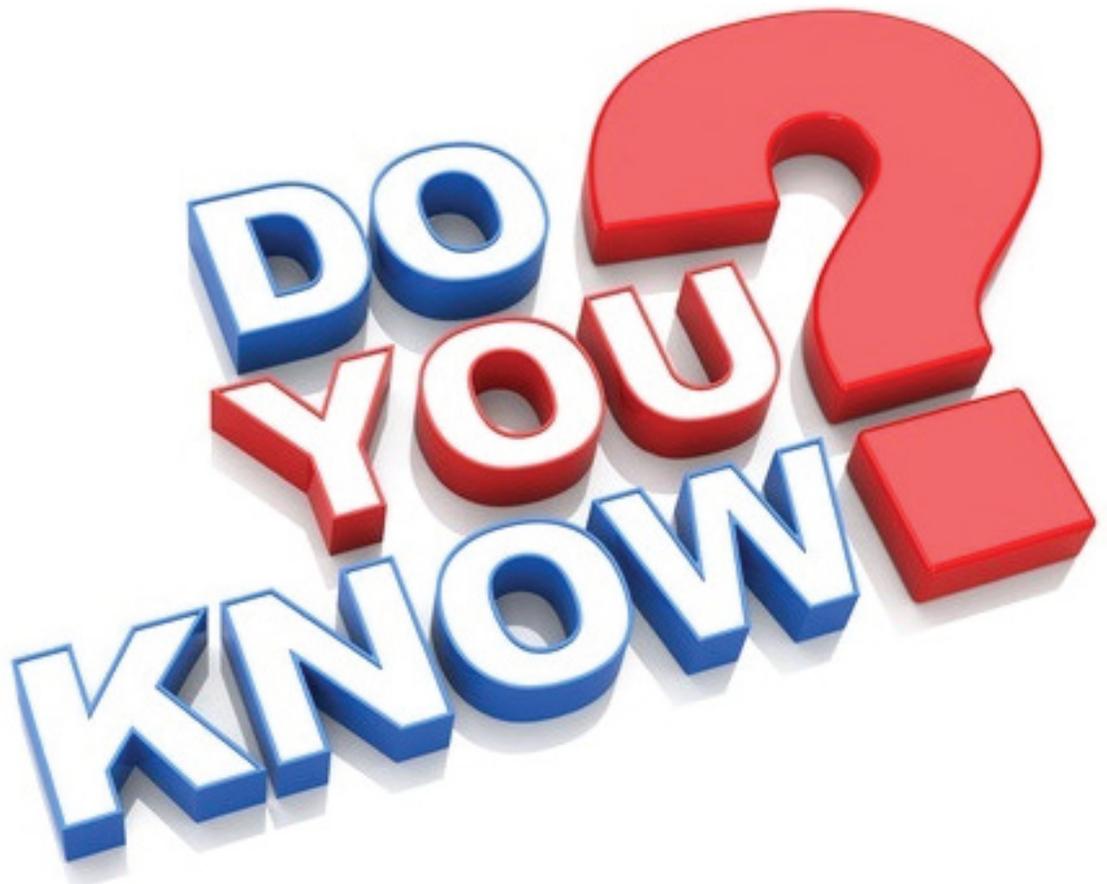

Will Rogers State Historic Park memorializes the ranch and home of this multi-talented celebrity. Take a tour of the 31-room ranch house with its perfectly preserved 1930's style or enjoy a guided trail ride right in Los Angeles.

For a real getaway, visit Mount San Jacinto State Park, a dedicated high-country wilderness area in Riverside County. Traverse the canyons in the Palm Springs Aerial Tramway as you climb to 8,516 feet.

Tucked between Corona Del Mar and Laguna Beach, Crystal Cove State Park is a hidden jewel that blends the best of sandy beaches, gentle hills and deeply wooded canyons. The offshore underwater area is perfect for snorkelers and scuba divers.

Malibu Creek State Park features 15 miles of stream-side trail through woodlands on chaparral-covered slopes. Learn about Chumash Native American life at the restored Sepulveda Adobe and use your imagination to picture TV shows like M*A*S*H being filmed there.

Here's a delicious variation to your next fish dish.

Ingredients

- 2 tablespoons butter
- 1/4 cup orange juice
- 2 tablespoons lime juice
- 1 tablespoon lemon juice
- 1 lb fish (cod, haddock, walleye)
- salt
- pepper

Directions

1. In small pan, melt butter, add juices.
2. Spray 13x9 pan with cooking spray.
3. Place fish in pan. Salt & pepper to taste.
4. Pour butter-juice mixture over fish.
5. Bake 400 degrees for 15-20 minutes or until easily flakes with fork.
