### **Discrimination and Workers' Compensation**

The law dictates that when an employee has a work-related injury or illness, the employer must cover the cost of any necessary medical care and reimburse the employee's lost wages during this period. When they discriminate against you for taking advantage of your right to compensation, they are committing a crime.

Your employer may occasionally dismiss or demote employees who want workers' compensation. Some employers might oppose being held accountable for the employee's continuous medical care or compensating

them for lengthy time away from work. In other instances, your employer or their insurance provider may try to prevent workers' compensation claims from being filed by employees or delay such claims.

Employees in the US are shielded from discrimination if they pursue workers' compensation benefits.

#### The Different Types of Discrimination

How employees can be discriminated against can range from finding a cause to keep an injured person from returning to employment to quietly taking away their duties. Your employer may discriminate or retaliate against you in the following manner:

- Cutting pay or sidelining you because of filing a claim.
- Denying you a promotion or even demoting you
- · Terminating or laying you off
- · Creating hindrances in the claim procedure
- Threatening you

You may consider speaking with a <u>workers' compensation lawyer</u> to understand more about your rights and your alternatives for combating unethical behavior if your company's treatment toward you begins to change as soon as you file for workers' compensation.

Your workers' compensation attorney will thoroughly investigate your case, including an in-depth review of your employer, and any related prior suits, discriminations, demotions, or terminations. Unfair terminations or demotions after workers return to work are common problems.

It is crucial to remember that companies can still take reasonable action against an employee. Employees who perform poorly or have a poor attendance history after a workers' compensation claim may be demoted, moved, or legally dismissed.

#### Is anyone around you being discriminated against?

If you think someone is being discriminated against, keep your emotions in check and avoid saying anything that can adversely affect you in court. Consult a lawyer as soon as you can. All correspondence, talks, or events that could serve as evidence of prejudice should be documented. You could require other employees to act as witnesses.

By taking action, you will make the workplace better for other workers like you and guarantee that you get the financial support you need to recover from an injury or illness. If you believe you are facing prejudice after filing your workers' compensation claim, contact a workers' compensation attorney immediately.

### Recipe of the Month: Mediterranean Pasta Salad

You'll love this easy pasta salad recipe! It's a great one to make ahead - if you're bringing it to a picnic, prep it up to a day in advance.

#### Ingredients

- 3 cups uncooked fusilli pasta
- 2 heaping cups of halved cherry tomatoes
- $1\frac{1}{2}$  cups cooked chickpeas, drained and rinsed
- 2 cups arugula
- 1 cup Persian cucumbers, sliced into thin half moons
- 1 cup crumbled feta cheese
- 1 cup basil leaves, torn
- ½ cup minced parsley
- <sup>1</sup>/<sub>2</sub> cup chopped mint
- <sup>1</sup>/<sub>4</sub> cup toasted pine nuts

#### Dressing

- 1/4 cup extra-virgin olive oil, more for drizzling
- 3 tablespoons lemon juice
- 1 teaspoon Dijon mustard
- 3 garlic cloves, minced
- 1 teaspoon of herbs de Provence, or dried Italian seasoning
- ¼ teaspoon red pepper flakes
- <sup>3</sup>⁄<sub>4</sub> teaspoon sea salt

#### Instructions

- 1. Bring a large pot of salted water to a boil. Prepare the pasta according to the package directions, or until slightly past al dente.
- 2. Meanwhile, make the dressing. In a small bowl, whisk together the olive oil, lemon juice, mustard, garlic, herbs de Provence, red pepper flakes, and salt. (Note: the dressing will have a strong flavor. It'll mellow once it coats all of the pasta salad ingredients).
- 3. Drain the pasta, toss it with a little olive oil (so that it doesn't stick together), and let it cool to room temp. Transfer to a large bowl with the tomatoes, chickpeas, arugula, cucumbers, feta cheese, basil, parsley, mint, and pine nuts. Pour the dressing and toss to coat. Season to taste with more lemon, salt, pepper, and/or a drizzle of olive oil, if desired, and serve.
