Recipe of the Month:

Mint-Cucumber Tomato Sandwiches

A simple and straightforward idea for a very tasty and quick lunch or snack on a hot summer day

Ingredients:

- 3 tablespoons butter, softened
- 8 slices sourdough bread or bread of your choice
- 1 Large cucumber, thinly slices
- 1 medium tomatoes, thinly sliced
- 1/4 teaspoon salt
- 1/8 teaspoon pepper
- 1/4 cup fresh mint leaves

Instructions:

1. Spread butter over 4 slices of bread.
2. Layer with cucumber and tomatoes.
3. Sprinkle with salt, pepper, and mint.
4. Top with remaining bread.
5. If desired, cut each sandwich into quarters.
